**SECTION 2: HAZARD(S) IDENTIFICATION**

**EMERGENCY OVERVIEW:** Amber liquid with no odor. Causes moderate to serious eye irritation.

### SECTION 4: FIRST AID MEASURES

<b>IF IN EYES:</b>	Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes; then continue rinsing eye. Call a poison control center or doctor for treatment advice.
<b>IF ON SKIN:</b>	Take off contaminated clothing. Rinse skin immediately with plenty of water for 15 to 20 minutes. Call a poison control center or doctor for treatment advice.
<b>IF INHALED:</b>	Move person to fresh air. If person is not breathing, call 911 or an ambulance; then give artificial respiration, preferably mouth-to-mouth if possible. Call a poison control center or doctor for further treatment advice.
<b>IF INGESTED:</b>	Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.

**SECTION 6: ACCIDENTAL RELEASE MEASURES**

- Environmental Precautions:** Keep spilled material and any rinsate from contaminating soil or from entering sewage and drainage systems and bodies of water.
- Methods for Containment:** Isolate the spill area. Keep unnecessary and unprotected personnel from entering and eliminate sources of heat, sparks or flames. Absorb small spills with sand, vermiculite or other inert absorbent. Avoid using combustible materials such as sawdust or cloth rags. Dike large spills using absorbent or impervious material such as clay or sand. Recover and contain as much free liquid as possible for reuse. Allow absorbed material to solidify and scrape up for disposal.
- Methods for Clean-up:** Place contaminated material in appropriate container for disposal. After removal, flush contaminated area thoroughly with water. Pick up wash liquid with additional absorbent and place in a disposable container. Do not put spilled material back in the original container.
